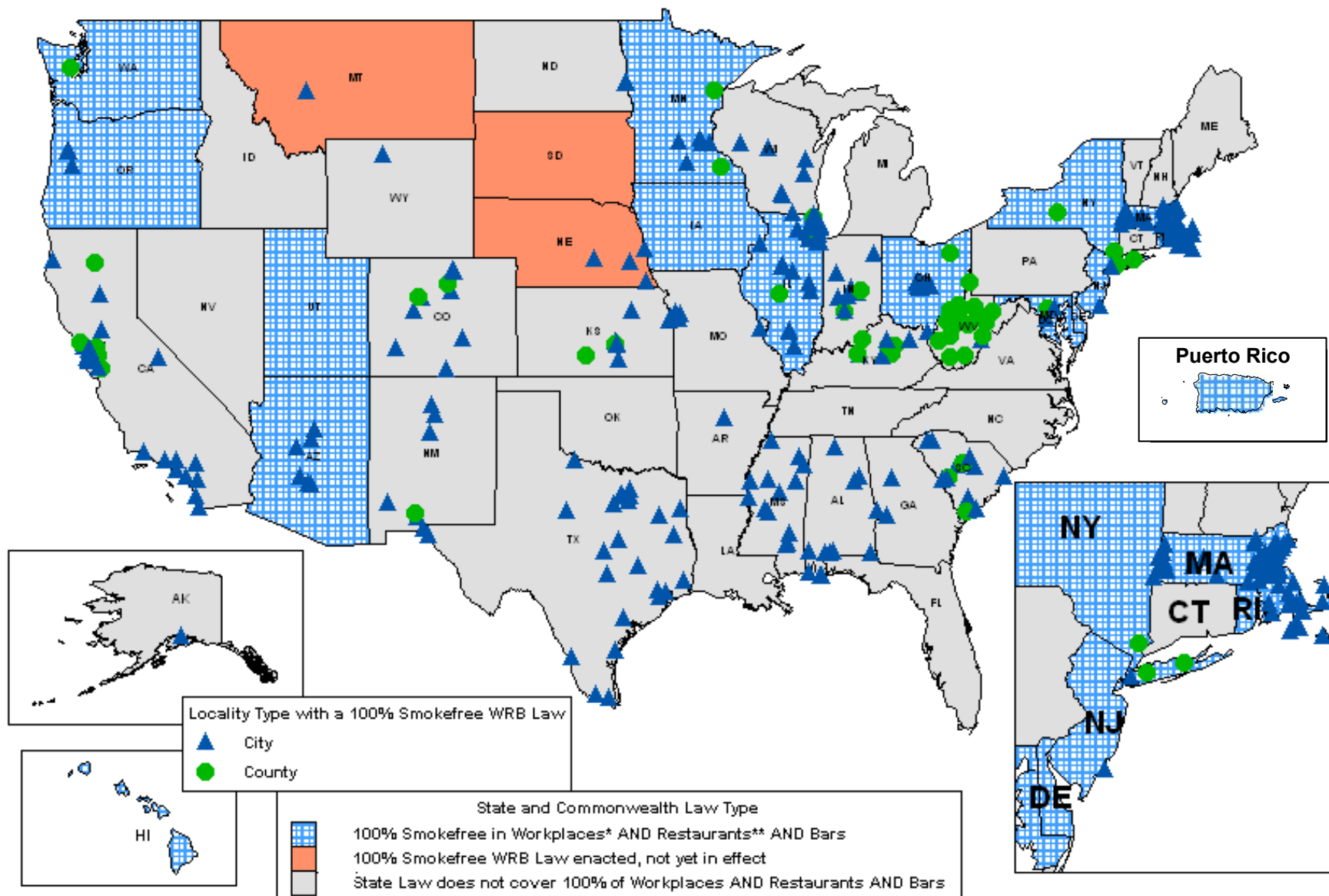

Note: The following state laws have been passed by legislature and signed by governor but are not yet in effect:

- **Montana** enacted a 100% smokefree workplace and restaurant law that became effective October 1, 2005, and a 100% smokefree bar law that is scheduled to go into effect October 1, 2009.
- **Nebraska** enacted a 100% smokefree workplace, restaurant, bar, and gaming facilities law, which is scheduled to go into effect June 1, 2009.
- **South Dakota** enacted a smokefree workplace law that became effective July 1, 2002, and a 100% smokefree restaurant and bar law that is scheduled to go into effect July 1, 2009.
